Section 4 - First Aid Measures

Eye Exposure: In case of contact with eyes, flush with copious amounts of water for at least 15 minutes. Assure adequate flushing by separating the eyelids with fingers. Get immediate medical advice.

Dermal Exposure: In case of skin contact, flush with copious amounts of water for at least 15 minutes. Remove contaminated clothing and shoes. Get immediate medical advice.

Oral Exposure: If swallowed, get immediate medical advice. Do not induce vomiting. Rinse mouth with water. After rinsing, drink small quantities of water (stop if the exposed person feels sick as vomiting may be dangerous).

Inhalation Exposure: If inhaled, remove to fresh air. If breathing becomes difficult, give oxygen. Get immediate medical attention.
