Section 4 - First Aid Measures

Eye Exposure: In case of contact with eyes, flush with copious amounts of water for at least 15 minutes. Assure adequate flushing by separating the eyelids with fingers. Seek immediate medical advice.

Dermal Exposure: In case of skin contact, flush with copious amounts of water for at least 15 minutes. Remove contaminated clothing and shoes. Seek immediate medical advice.

Oral Exposure: If swallowed, seek immediate medical advice. Do not induce vomiting. Rinse mouth with water. After rinsing, drink small quantities of water (stop if the exposed person feels sick as vomiting may be dangerous).

Inhalation Exposure: If inhaled, remove to fresh air. If breathing becomes difficult, give oxygen. Seek immediate medical attention.

Procedure(s) of Personal Precaution(s):
